

This Contract, Made the 8th day of May 19 58 BETWEEN The Cherry Hill School District of Wayne County, State of Michigan, hereinafter called the School District,

and John Souve of E. Lansing, Michigan hereinafter called the Teacher.

Witnesseth: Said Teacher being certificated to teach in the Public Schools in said County and State hereby contracts with said School District for the school year of 10th months commencing the 2nd day of September 19 58 and said School District hereby contracts to hire said Teacher to teach as herein

set forth, in consideration for which said School District will pay to said Teacher the sum of \$1875.00

Four thousand eight hundred seventy-five and no/100----- Dollars,

(includes \$4500 basic - plus \$375 for coaching 3 sports) payable in 26 equal installments as follows: (1) Payable on alternating Fridays commencing

September 12th, 1958. (Excluding six months for military obligation.)

The services of the Teacher shall consist of teaching in the Public School of said School District; the Teacher shall not be required to perform any other services not connected with the Public Schools. (2)

The Teacher is subject to assignment and transfer at the discretion of the Superintendent of Schools or the Board of Education.

It is further agreed that the said teacher will be allowed leave of absence, in accordance with the rules and regulations of the Board of Education, for (10) ten days/or one day per teaching month, during the school year covered by this contract, the unused portion of the leave of absence to accumulate to sixty (60) days.

The teacher shall be allowed two personal business days during the year, for the tenure of this contract.

The teacher shall not carry more than four semester hours per semester, and beginning teachers are advised to carry no hours for the semester.
